According to Article 7 of the law in the new edition, it is directly stated that the self-governing bodies of citizens are not part of the bodies of state power [4], several amendments and additions were introduced to the law on self – government bodies of citizens in the new edition approved by the Senate of the Oliy Majlis on March 28, 2013, on September 14, 2017.

In the new edition of the law, the organizational and legal basis of the activities of the citizens' gatherings was strengthened. There:

- self-governing bodies of citizens implementation of measures to support the strata of the population against social injustice;
- identify families, lonely pensioners and disabled people who need social assistance in conjunction with social assistance centers for assistance and protection of the population;
- in connection with the provision of employment assistance to citizens residing on the territory of the Republic of Uzbekistan established norms of immigration [5].

The Institute of self-management of citizens, which has become an obvious template for the whole world in ensuring the tranquility of our country, which is currently developing, namely, the role of the neighborhood is incomparable. In the new country of Uzbekistan, which is taking a step to the third renaissance, today there are wide opportunities for all spheres, and as a result of carefully developed reforms, radical changes are being made. In particular, on March 5, 2021, the Cabinet of Ministers adopted a resolution "on measures to further improve the system of social protection of the population, as well as to introduce modern information and communication technologies into the sphere". In accordance with the resolution, a single electronic database with the ID identification number and territorial limit of each neighborhood was introduced in Uzbekistan. Until April 1, 2021, the following were developed and introduced.

With the initiatives of our President Sh.M. Mirziyoyev, the Institute of the neighborhood, which have been carried out in the country under the pretext of becoming a colleague and supporter of the people in places, the scales of justice, undoubtedly further strengthen people's trust in the state, in order to support the importance of the neighborhood in social life, 2022 was declared the year of", according to the decree Nº PD-81 of March 1, 2022" on measures to improve the system of support of

neighborhoods and old peoples", the main tasks and areas of activity of the Ministry of support of neighborhoods and old peoples of the Republic of Uzbekistan were defined as follows:

- \* support the activities of neighborhoods, protection of their rights and legitimate interests, development of proposals for the development of the neighborhood system:
- \* to enhance the role and role of neighborhoods in society, to work with the everyday problems of the population and to raise their status in the implementation of effective public control;
- \* broad involvement of old people and the elderly in strengthening families in neighborhoods, preserving national and universal values, educating young people in the spirit of love for the motherland, respect for traditions such as kindness and compassion;
- \* implementation of legislative acts on the sphere of support for the elderly and the including coordination of medical and social services to representatives of the older generation in the regions, especially remote villages;
- \* to provide social and material support to the elderly in need of the care of others, to study their problems and to take measures to solve them jointly with the concerned government bodies and organizations:
- \* implementation of measures aimed at improving the material and technical supply of neighborhoods and introduction of modern information and communication technologies [6].

Any person who has a sense of national consciousness, self-esteem, history, formed a worldview, is constantly active in social life, in relationships. A person who is indifferent to reality will be a citizen who serves not only for the development of society, but also for its degradation.
